Prior to the Fall of 2016, courses were graded on an Satisfactory/Unsatisfactory basis. Beginning with the incoming class in Fall 2016, courses are graded on a Pass/Fail basis. In the event that a student must complete additional work for a course, a Conditional grade is assigned, which becomes a Conditional Pass upon completion.

Neither grade point average nor class rank are used in this grading system. Honors may be received in the following disciplines: Family Medicine, Medicine, Obstetrics/Gynecology, Pediatrics, Psychiatry, Neurology, Surgery, Emergency Medicine, Critical Care, Advanced Inpatient Experience, and Radiology.

The School of Medicine was non-credit bearing (with the exception of Phase 1 Electives) prior to the Fall of 2018.

The UConn School of Medicine transitioned to a new curriculum (MDelta) with the incoming class in fall 2016. Students who matriculated prior to that year continued in the Legacy curriculum. Students who left to complete the Ph.D. portion of their dual degree training may have spanned both curricula.

The Legacy curriculum was divided into 3 Phases. The MDelta curriculum began in July 2016 and is divided into three stages: Exploration; Clinical Immersion; Transformation and Entrustment.

The University of Connecticut Schools of Medicine and Dental Medicine underwent a Student Records conversion on January 12, 2019. The curriculums contain multiple longitudinal courses which span two or more academic terms. All courses and grades are present on the transcript however the formatting by term may not align directly with course dates. Longitudinal courses may appear with placeholder grades in the first term of a course (*, Y, IP, NR, R).
